## BUFFALO, RICE, ROCK LAKES ASSOCIATION BOARD OF DIRECTORS' MEETING SATURDAY, MAY 5, 2018 RICHWOOD WINERY

**Call to Order**: President Wolf called the meeting to order at 9:30 am. Attending were Kevin Wolf, Becky Burns, Betty Hund, Rick Morris, Jessica Franke, Tom Foltz, Chris Krogsgaard, Roger Levos, Rich Ceislak, Bryan Olschlager, Chris Krogsgaard, and Deb Krogsgaard.

**Secretary's Report:** A motion was made by Bryan and seconded by Becky to accept the May 2017 Secretary's Report as printed. Motion carried.

**Treasurer's Report:** Becky provided a detailed report (attached.) The ending balance for the checking account is \$2,171.81. Rick made a motion to approve the treasurer's report, seconded by Roger. Motion was carried.

## **Old Business:**
